



## EXPECTATIONS OF STUDENTS/PARTICIPANTS

July Experience is designed for mature, thoughtful, and responsible students. We provide participants with an environment that is structured yet provides for freedom in which we encourage interaction, self-discovery, and development of friendships with other participants and faculty. Our community is grounded in respect and the willingness to maintain an open mind. We require that each student read, understand, and abide by the rules and regulations of the program.

1. July Experience participants will take full responsibility for upholding the Davidson College Honor Code and Pledge (included on back of page) which will be signed at the beginning of the program.
2. Participants are expected to attend class every day, and all required or mandatory programs, as indicated on the July Experience schedule.
3. No participant may leave campus or any official program activity, including off-campus excursions, without the express permission of the July Experience Director.
4. Participants are to respect the personal space and property of other participants and Davidson College property and staff, and maintain a safe and healthy environment for all participants to live and study.
5. Curfew and quiet hours begin at 11:00pm. Participants are expected to be in their own dorm at that time. There is no visitation in dorm rooms of the opposite sex at any time.
6. Any damage to college property will be paid for by the responsible participant. If it is impossible to determine the individual at fault, the entire group involved will be assessed damages.
7. Smoking of cigarettes, e-cigarettes, or use of other tobacco products is not permitted and strictly prohibited in Residence Halls.
8. **The use or possession of illegal drugs or alcohol by a participant on campus or at any July Experience activity away from campus is grounds for immediate dismissal from the program with no refund.**
9. **Any disciplinary referrals will go through the July Experience Director. You may be dismissed from the program without refund if (1) you are creating an unsafe environment for other participants; (2) you are referred to the Director more than once for a documented disciplinary issue; (3) you are unable to uphold the Expectations of Students.** *If dismissed, the participant will be responsible for arranging travel to leave the program and any costs incurred.*

The Expectations of Students and observance of the Honor Code are meant to strengthen our community by promoting honesty, accountability, and respect. These expectations are not to be taken lightly and will ideally enhance the experience of all participants in the program. Please sign below and return by **May 22, 2019**.

## **HONOR CODE**

Each July Experience student is honor bound to refrain from stealing, lying about College business, and cheating on academic work. Stealing is the intentional taking of any property without right or permission. Lying is intentional misrepresentation of any form. Cheating is any practice, method, or assistance, whether explicitly forbidden or unmentioned, that involves any degree of dishonesty, fraud, or deceit. Cheating includes plagiarism, which is representing another's ideas or words as one's own. Additional guidelines for each class may be determined by its professor; each July Experience student is responsible for knowing and adhering to them. Each student is responsible for learning and observing appropriate documentation of another's work. Each July Experience student is honor bound to report immediately all violations of the Honor Code of which the student has first-hand knowledge; failure to do so is itself a violation of the Honor Code. All students, faculty, and other employees of Davidson College are responsible for familiarity with and support of the Honor Code. Any student, faculty member, administrative officer, employee, or guest of the College may charge a student with a violation of the Honor Code.
