

PURSUANT TO NCGS § 99E-71(b), PLEASE TAKE NOTICE OF ACTIONS TAKEN BY DAVIDSON COLLEGE FOR THE PURPOSE OF REDUCING THE RISK OF TRANSMISSION OF COVID-19 TO INDIVIDUALS PRESENT ON THESE PREMISES.

- Our foundational priority is the safety, health and well-being of our students, faculty, staff and visitors.
- We are committed to protecting you from the spread of infection.
- We are using reasonable efforts to follow safety recommendations from the CDC and infection prevention experts.

WEAR A FACE COVERING: We require that everyone must wear a face covering while on our campus. Davidson College has provided two reusable cloth face coverings to every student, faculty and staff member. The CDC recommends that children over the age of two should wear a face covering. The face covering should be properly worn over your nose and mouth. If you are a Davidson College faculty or staff member and you do not have a face covering, please contact Human Resources at 704-894-2213 and masks will be provided to you.

PRACTICE GOOD HAND HYGIENE: We strongly encourage good and frequent hand hygiene, which includes the use of alcohol-based hand sanitizer or handwashing with soap and water for at least 20 seconds.

PARTICIPATE IN DAILY SYMPTOM MONITORING: We require that all students and on-campus faculty and staff must complete a daily symptom screening process and log their results using a symptom monitoring app. Students who are experiencing COVID-19 symptoms have been instructed to immediately contact Student Health and Well-Being at 704-894-2300 for clinical evaluation and potential quarantine instructions.

We require that all faculty and staff members who are required to work on campus conduct daily symptom monitoring before reporting to work. Faculty and staff members who are experiencing COVID-19 symptoms will not be permitted to enter our facilities and are instructed to stay at home and contact Human Resources by calling 704-894-2020 to discuss their medical status.

MAINTAIN PHYSICAL DISTANCE: We expect that everyone who enters our facilities should maintain at least a six-foot physical distance from others, where and when possible, at all times.

LIMIT NUMBER OF VISITORS: We have limited the number of people who enter our facilities, who gather, study and work in our spaces and who provide vendor services, goods and equipment to us.

ENHANCED CLEANING & FACILITY CHANGES: We have initiated enhanced cleaning protocols throughout our facilities. We have altered spaces within facilities in an effort to reduce the risk of infection transmission.

PERSONAL PROTECTIVE EQUIPMENT: We supply appropriate PPE to our students, faculty and staff members, and require that it is worn in our campus environment.

STUDENT & EMPLOYEE EDUCATION: We provide on-going education and communication to our students, faculty and staff members in an effort to reduce the risk of infection transmission.
